



## The Solar Water Heater Tune-Up Spring Giveaway PY25 OFFICIAL RULES

Official Rules for "Hawai'i Energy Solar Water Heating Tune-Up Giveaway", **January 7 – February 7, 2026**.

Hawai'i Energy will conduct this contest giveaway as described in these general contesting rules, and each participant agrees to the following:

By Playing, each participant accepts and agrees to be bound by these official rules. **NO PURCHASE NECESSARY.** Participant must have a solar water heating system in order to receive the prize service. Participant agrees to be opted in for email communications from Hawai'i Energy and can opt out at any time after this contest has concluded. Must be 18 years of age or older, a fulltime resident of Hawai'i and an electric utility ratepayer on the island of Hawai'i, Maui, Moloka'i or O'ahu to participate. **Residence must have a solar water heating system where participant is allowed to make decisions on servicing the system.** If you are not able to make those decisions, Hawai'i Energy reserves the right to award the prize to another entrant. Multiple submissions will not be accepted. Void where prohibited.

Employees and immediate family members of employees of Hawai'i Energy and their respective parent companies, affiliates, subsidiaries, suppliers, and their advertising and production agencies (collectively, the "Sponsors") are not eligible to participate.

Illegible cards will be discarded and deemed void. No facsimile or copies will be allowed. Sponsors are not responsible for lost, late, illegible, incomplete or misdirected entries.

Any valuation of the prize is based on available information provided to Hawai'i Energy, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winner is solely responsible for reporting and paying any and all applicable taxes related to the prize and paying any expenses associated with any prize which is not specifically provided for in the official rules. The winner must provide Hawai'i Energy with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded and will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.

Only the prize winner may claim the prize. No proxies permitted. Prior to delivery of the prize, winner is required to execute a Release and Affidavit of Eligibility that must be received by the Sponsor within ten (10) days from winner's receipt of the Release and Affidavit of Eligibility form. Upon completion and verification of winner's tune-up service, Hawai'i Energy agrees to pay the participating [Clean Energy Ally \(Alternate Energy if on Oahu or, if outer island, the participating Clean Energy Ally of winner's choice\)](#) up to \$450 of the cost. If the winner is from Maui, Hawaii Island, Molokai, or Lanai, they must, instead, select a [Clean Energy Ally who services their area](#) (options available at [hawaiienergy.com/find-a-contractor](http://hawaiienergy.com/find-a-contractor)) and notify Hawai'i Energy who will coordinate scheduling the service. Winner agrees to schedule and complete the service **no later than June 30, 2026**. Hawai'i Energy is not responsible for the maintenance of the unit or any other associated costs relating to the operation or installation of the unit. Winners will be required to fill out a program application for the service.

Prize may not be exchanged for cash. No substitution of prize permitted. The depiction of the prize in any advertising or promotional materials may not reflect the actual prize to be awarded. Winner may not transfer the prize.

Entries will be reviewed beginning **February 8<sup>th</sup>, 2026** and the winner will be contacted by phone and/or e-mail no later than **February 9<sup>th</sup>, 2026**. If winner cannot be contacted by **February 9<sup>th</sup>, 2026**, or is disqualified for any reason, Hawai'i Energy reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

Winner agrees to the use of his/her/their name(s) and likeness(es), without any additional compensation, by sponsors for publicity.
